## **Highlights from the February Meeting:**

The meeting was called to order at 7:23 by club president, Jerry Skoll, KC9DTB. There were just over 60 in attendance for the meeting. Jerry announced that the club will charter a bus to go to Dayton for the Dayton Hamvention again this year on May 19. Jerry announced that show tickets for Dayton are available on line with no credit card surcharge. Jerry also announced that the meeting schedule has been changed: the March meeting will now be on VOIP, presented by Dave Gingrich, K9DC. April will be on Antennas, presented by Tom Chance, K9XV (this is unchanged). The May meeting will be on kit building, where those in attendance will be able to build a Pico-Keyer kit. This is the kit that was in the January QST. Cost is \$18 each for the kit. Jerry asked how many were interested in working on a kit, and how many would be willing to have an extended meeting to accommodate the kit building. There was a good response to both questions. There will be a sign up sheet at the March meeting, so the kits can be ordered. Rhonda Curtis, W9SH announced that the VE session on Saturday, February 11 would be run by Jim Rinehart, K9RU, since she will be tied up with the class and test in Johnson County. Dr. Jay Wright, KK9L, said classes in Hendricks county are going well. CDs have been passed out for study. Jerry asked for some comments from Superbowl volunteers. Carl Ashmore, KC9EVI, said it was a great experience. He found all of the

activities outside of the game were the most interesting. All of the ham volunteers involved had the highest level of credential. They worked primarily with the media, to prevent interference issues. As media came in, their gear was checked to make sure they were operating where they should be. Doug Rose, N9DR, added some input, he was assigned to "DF" those that were operating where they weren't supposed to. Charlie Sears, N9MEW, said he had a report that there were some 3500 frequencies in use that day. Jerry announced that our field day site is not available this year, so we are exploring some other options, such as Fort Ben, Lilly, Broad Ripple, etc. Tom Chance will be in New Mexico for field day this year. Bob Blake, N9FIM, announced the Marion County severe weather spotter seminar will be March 24, at 9:00 at the Masonic Lodge located at 7502 E. 56th street. Jay,KK9L, announced the he had attended some classes involved with EmComm. The AuxComm class was a good one, focusing on how we can help with emergency communications as amateurs. The CommT class will be hands on. The Brownsburg hamfest will be February 25 at the American Legion Post in Brownsburg.

Next Dave Miller, K9RTT, introduced the speaker, Don Hornback, for the evening regarding Heathkit. There were several Heathkit models on display that folks had brought in. Don said almost as soon as he was hired on to IVY Tech, Dave started talking to him about putting on a program for the club. Heathkit was started by Edward Bayard Heath in 1918, purchased an aeroplane company. He sold plane kits. Had several kit options for the plane ranging from \$99 to \$999. Bayard was killed in 1931 during the testing of a new plane. The company went bankrupt in 1935. Howard Anthony bought Heath Company for \$300, and moved it to Benton Harbor. During WWII, he was moving to electronics. In 1947, they started a line of instruments. In 1954, Anthony died in a plane crash. Don said Heath was the best company that he had ever worked for. Don went over the Heathkit designs that he did. Kit business closed in March of 1992. Heath Educational Systems still exists. The most successful line for Heath was test instruments, followed by ham radio.

Door Prizes were distributed. Jerry reminded everyone to bring their checkbooks to the next meeting for the bus trip to Dayton.

#### AMATEUR RADIO GETS SECONDARY MF ALLOCATION

It's official -- delegates attending the 2012 World Radiocommunication Conference (WRC-12) have approved a new 7-kilohertz-wide secondary allocation between 472-479 kHz for the Amateur Radio Service. Agenda Item 1.23 had both its first and second readings in Plenary Session on Tuesday, February 14; to become part of the ITU's Radio Regulations, each Agenda Item **must be read twice in Plenary Session**. While the Final Acts will be signed on Friday, February 17 at the close of the Conference, the new allocation will not take effect until it is entered into the Radio Regulations. No date has been set for this, but it is unlikely to be earlier than January 1, 2013. In any case, no amateur can use the band until his or her national regulations are revised to implement the allocation. In April, the sessions are going to go back to alternating Monday night test sessions with Saturday test sessions. "We were pleasantly surprised at how many folks came out for Monday evening testing."

#### **NEW 60 METER RULES GO INTO EFFECT MARCH 5**

On November 18, the FCC released a Report and Order (R&O), defining new rules for the 60 meter (5 MHz) band. These rules are in response to a Petition for Rulemaking (PRM) filed by the ARRL more than five years ago and a June 2010 Notice of Proposed Rulemaking (NPRM). In the February 3 edition of the Federal Register, the FCC announced that these new rules will go into effect at 12:01 AM (EST) on March 5, 2012.

In summarizing the new rules, the FCC explained that the new rules amend the current rules to facilitate more efficient and effective use by the Amateur Radio Service of five channels in the 5330.5-5406.4 kHz band (the 60 meter band): "Specifically, and consistent with our proposals in the *Notice of Proposed Rulemaking* in this proceeding, the Commission replaces one of the channels with a less encumbered one, increases the maximum authorized power amateur stations may transmit in this band and authorizes amateur stations to transmit three additional emission designators. The Commission also adopts an additional operational rule that prohibits the use of automatically controlled digital stations and makes editorial revisions to the relevant portions of the Table of Frequency Allocations and our service rules."
