Highlights from the March Meeting:

Club president Jerry Skoll, KC9DTB, called the meeting to order at 7:20. There were over 70 present for the meeting. Jerry recognized recent upgrades and new licensees. Rhonda Curtis, WS9H, reported on testing sessions. She had 8 out of 8 of a one day class pass their license exams. She also reported that on March 23, 4:30 pm, there will be a testing session at the Lighthouse Readiness team facility. Dr. Jay Wright, KK9L, reported on the recently completed Hendricks county classes and testing. They had a 100% pass rate.

Mike Palmer, N9FEB, announced the upcoming events for central Indiana that will need ham radio volunteers. He went through all the events, saying that he draws volunteers from 9 counties for the mini-marathon. Mike said if anyone would like to volunteer for any events, to contact him at <u>n9feb@comcast.net</u> or via his web site, <u>http://indyhams.org/</u>. Bob Blake, N9FIM, reminded those present that March 24 is the Marion County severe weather seminar, held at 7502 E. 56th St., at the Masonic Lodge, just east of North Central High School. Wednesday March 21st will be the state severe weather drill. Bob said if the state calls for nets during this test, he will run the nets. All Marion County severe weather nets are on the 146.76 repeater. Bob said it's best to use 151.4 hz tone to prevent interference with other repeaters on that frequency in the region.

The 146.700 repeater will be the back up if the .76 goes down. The 443.25 KM9E 70cm repeater will be linked to the 146.76 during weather nets. Ron Cooper, WB9DKL, talked about the keyer kit that will be built at the May meeting. The kit is available at <u>http://www.hamgadgets.com/index.php?</u>

The kit is \$17.99, and the box is \$8.01, plus shipping. Jerry talked about the membership decline that has been noticed. Jerry said a survey will be sent out to find out what the membership thinks about questions such as, Is Friday night the right night? Are programs good, need something other? Other activities? Foxhunt, shootout? Do we need another meeting location? Monthly show and tell was mentioned as was the possibility of having trade and/or sale items at meetings. The survey will be sent via email.

Jerry Read a note he received from a lady who is conducting research for a paper she is writing about her father, who was a ham around the 20s. Dave Spoelstra, N9KT, took her information, and will follow up with her. Jerry reminded everyone about the bus trip to Dayton, \$30 per person [SEE REGISTRATION FORM AT END OF NEWSLETTER]. Jerry gave an update on Field Day. Camp Belzer is out, since we wouldn't be able to get in until 1:00 pm. Jerry solicited the group about what they were looking for in a facility. Greg Herman, KC9NRO, mentioned the Interstate battery discount available at the Avon store, just west of Raceway, and the 21st and Shadeland store will do 10% discounts for club members, with valid membership card.

Next Jerry introduced Dave Gingrich, K9DC, for his presentation on VoIP and IRLP. Dave was first licensed in 1965. He is representing the Digital Radio Experimenters Group (DREGs). Dave gave a basic block diagram for a basic repeater and talked about methods of linking multiple repeaters together. Methods from basic telco line to RF linking, to VoIP via Internet. This became IRLP (Internet Linking Radio Project), in 1996, by David Cameron, VE7LTD. There are currently in the neighborhood of 2800 nodes/repeaters registered on IRLP. IRLP is 100% radio, "keeping radio in amateur radio". Dave went over the 3 codecs for VoIP set up, ranging from GSM to HD (good quality to best quality). All that is required to use IRLP is a radio with a touchtone pad. Dave stated there are no restrictions on putting a node on the air. The PC needed for the node is very low quality, any speed Pentium II or so with minimum RAM (128MB). The only special item is the IRLP interface board from IRLP.net and the software needed. Dave showed a couple of "all in one" boxes that have computer and radio interface, or radio in one box. Dave went over the basics of operation, dial 4 digit code to connect, dial "73" to disconnect. He talked about IRLP "Reflectors", where more than two nodes can be connected together. Most reflectors in IRLP are located in commercial servers due to the increased bandwidth needed for the reflectors. There are a total of 30 reflector sites in the world for 300 unlimited capacity channels of conferencing. There are lots of

nets on IRLP, including the "New Years Eve around the world" net that Dave initiated a few years ago. Dave runs a couple of repeaters in Indy, K9IP 443.425, and K9DC on 147.315. Dave went over the meanings of the different courtesy tones on his local repeaters. Dave talked about the IRLP/Echolink interface, utilizing the lowest codec. Dave next demonstrated the IRLP status web page (<u>http://status.irlp.net/</u>), and then demonstrated how to connect utilizing his hand-held radio. Those present showed their appreciation for Dave's great presentation.

Next month, Tom Chance, K9XV, will be making his annual presentation on antennas. Door prizes and adjournment at 8:55 pm.

Ham Radio News:

PAYROLL TAX BILL INCLUDES PROVISION FOR AMATEUR RADIO STUDY

The ARRL reports on a bill that could result in recommendations to remove unnecessary restrictions on amateur radio residential antenna installations. A bill that has passed both the House and the Senate includes a provision for a study of the uses and capabilities of Amateur Radio Service communications in emergencies and disaster relief.

If passed into law, Section 6414 of the Middle Class Tax Relief and Job Creation Act of 2012 mandates the completion of the study, with a report of the findings to the House Committee on Energy and Commerce and the Senate Committee on Commerce, Science, and Transportation.

This study would "use the expertise of stakeholder entities and organizations" to recommend how to best use radio amateurs in emergency communications and disaster relief efforts, and how to best utilize the Amateur Radio Service in coordination with the federal government in these efforts. In addition, the study would also discuss the effects of unreasonable or unnecessary private land use restrictions on residential antenna installations and recommend ways to remove such impediments.

DXCC NEWS

According to the Finnish Ministry of Transportation and Communication, the Saimaa Canal Treaty between Finland and Russia has been finalized by relevant Finnish and Russian authorities through ratification.

The Treaty has entered into effect with a date of February 17, 2012.

Malyj Vysotskij Island (MVI), R1M, is no longer included in the Treaty. Thus, MVI will be deleted from the DXCC list as of February 17, 2012, and added to the Deleted Entities List.

Administratively at HQ, we will not make the necessary changes to the DXCC system until after the final data processing for 2011 is complete -- this includes the tables shown in Logbook of The World. (The 2011 DXCC Annual and Honor Roll listings will contain M-V Island as it stood in 2011, a current entity). This change will affect the Honor Roll numbers as follows:

#1 Honor roll will drop to 340 (down from 341) The entry level Honor Roll number will drop to 331 (down from 332)

DXCC members will see their current entity totals drop by one on their Mixed awards, and on the bands and modes where MVI credit is given. They will also see their DXCC Challenge totals drop commensurately.

MORE DXCC NEWS

On and after April 2, 2012, here is how the DXCC fee system will change:

• No more hybrid applications. Each DXCC application -- be it paper QSLs, LoTW or Online DXCC -- will be considered separate applications with separate application fees.

• There are no limits on the number of applications that can be submitted. There will be no more surcharges added to the second or subsequent applications.

• A traditional, paper QSL application will have an application fee of \$15 for ARRL members, and \$25 for non-members. These applications will be allowed to include up to 101 QSOs. Additional QSOs in this sort of application will continue to cost 15 cents each.

• A DXCC application submitted using LoTW will have an application fee of \$5 for ARRL members and \$10 for non-members. There are no limits on the number of QSOs that can be included as part of a LoTW application. Each QSO used in LoTW for an award will cost 12 cents, down from a minimum of 15 cents in 2011. We will no longer sell LoTW "credits" in bulk. If you have credits stored, you will still be able to use them.

• DXCC staff will not mail any paperwork for LoTW applications (credit matrix or application summary), as all application information will be available online in the LoTW User account.

• An Online DXCC Application will have an application fee of \$7.50 for ARRL members and \$12.50 for non-members and will be allowed to include up to 101 QSOs. Additional QSOs will cost 8 cents. This application is primarily intended to be used in conjunction with field checkers, but can be used by applicants who do not have access to a card checker and are willing to ship cards to ARRL HQ.

• Certificates will still cost \$14 delivered in the USA, and \$16.50 delivered outside the USA. Pins will continue to cost \$7 delivered anywhere.

• The fee for an initial DXCC award will now be the same as for any DXCC application.

• The free DXCC Yearbook that was sent to ARRL members will now be made available electronically, and it will appear in an edition of Digital QST. For those who want a League-printed Yearbook, it will still be available at a modest cost.

NEW 60 METER RULES

As of March 5, US amateurs have new privileges on the 60 meter band. In addition to an increase in effective radiated power from 50 to 100 W, hams can now transmit CW and PSK31 on the following channel-center frequencies:

- Channel 1: 5332.0 kHz
- Channel 2: 5348.0 kHz
- Channel 3: 5358.5 kHz
- Channel 4: 5373.0 kHz
- Channel 5: 5405.0 kHz

Amateurs can also transmit USB voice and PACTOR III on the following suppressed carrier frequencies (the frequencies typically shown on transceiver displays):

- Channel 1: 5330.5 kHz
- Channel 2: 5346.5 kHz
- Channel 3: 5357.0 kHz
- Channel 4: 5371.5 kHz
- Channel 5: 5403.5 kHz
