Highlights from the March Meeting:

The meeting was called to order at 7:30 pm by club president David Spoelstra, N9KT. There were just under 40 in attendance.

David announced that Jim Rinehart, K9RU, has been working hard on the IVY Tech club station, and the station is operational on practically all ham bands. Contact Jim for access to the station. Access can be had on Monday afternoons.

Regarding Field Day, Jace Thompson, KD9BIG, will be coordinating the club's efforts, and Brian Smith, W9IND, will be coordinating scheduling. HDXCC, the RCA club, and SATERN will be joining forces with the IRC this year.

May 19 is the bus trip to Hamvention. *[check for more info in separate article following.]*

The club will once again be sponsoring the Hilltop competition, with Tony Stokes, KU9V, coordinating it again. More information to follow.

The Indiana QSO Party is May 5. Please remember to specify IRC as your club when submitting INQP logs. See more detailed info on the INQP later in this newsletter.

Special Event Station W9IMS is getting ready to fire up in May. Contact David, N9KT, Jim, K9RU, or Jay, W9TC, for more information.

Club treasurer Rhonda Curtis, WS9H, addressed a change in when member dues will be collected. In the past, everyone was on their "own schedule", with their dues being due on the "anniversary month" of their original membership. Rhonda announced the club's board of directors had approved that effective at the beginning of the 2018-19 club year, everyone's dues will be due at the September meeting, with new memberships coming in after September being on a pro-rated schedule.

David recognized 2 new hams in the audience, plus one ham new to the area.

Next, David introduced the evening's speaker, Kermit Carlson, W9XA, ARRL Central Division Director. Kermit has been licensed since the 70's, and is active on all bands from 10GHz to 160 meters.

Kermit gave a summary of some recent changes in the upper administration of the ARRL: Tom Gallagher, NY2RF, stepped down as ARRL CEO, effective March 1. Mr. Barry Shelly, N1VXY, was elected as interim CEO (former CFO), and Mrs. Diane Middleton, KC1BQF, was elected as CFO.

Kermit said the Official Observer (OO) program is going to be changing a bit, pending FCC approval. This is especially important with the FCC shutting down Field Offices. Kermit touched on the Public Service Enhancement Working Group. He also explained the new rules for DXCC country status: IARU Member Society AND US State Department recognition as an independent country.

Kermit also talked about the Life Long Learning Program, and announced that one of the things that has been recently enacted is upon the death of a Life Member of the ARRL, that Life Membership will transfer to the surviving licensed spouse.

Kermit addressed the Entry Level License Committee Report. This committee was formed due to concerns about the rising number of licensees choosing to let their licenses lapse. ARRL REQUESTS EXPANDED HF PRIVILEGES FOR TECHS

ARRL has asked the FCC to expand HF privileges for Technician licensees to include limited phone privileges on 75, 40, and 15 meters, plus RTTY and digital mode privileges on 80, 40, 15, and 10 meters. The FCC has not yet invited public comment on the proposals, which stem from recommendations put forth by the ARRL Board of Directors' Entry-Level License Committee, which explored various initiatives and gauged member opinions in 2016 and 2017.

Specifically, ARRL proposes to provide Technician licensees, present and future, with phone privileges at 3.900 to 4.000 MHz, 7.225 to 7.300 MHz, and 21.350 to 21.450 MHz, plus RTTY and digital privileges in current Technician allocations on 80, 40, 15, and 10 meters. The ARRL petition points out the explosion in popularity of various digital modes over the past 2 decades. Under the ARRL plan, the maximum HF power level for Technician operators would remain at 200 W PEP. The few remaining Novice licensees would gain no new privileges under the League's proposal.
