Highlights from the April Meeting:

The meeting was called to order at 7:35 by club vice-president Dave Miller, K9RTT. Dave opened the meeting with self-introductions. There were 35 present. Dave asked for volunteers to help with the Radio Club's table and prize table for the upcoming Indianapolis Hamfest. Jim Rinehart, K9RU, talked about a class that he and David Spoelstra, N9KT, hosted at Ivy Tech. See article later in this newsletter for more information on the class and new hams. Jim also talked about two petitions out now. One is a new entry level "CB" type license with very limited testing. The other petition is to give more spectrum to techs. See more information on these petitions later in this newsletter. Mark Burke, W9MGB talked about Field Day plans for the club, as well as the North Central Hamfest coming up.

Next, Dave, N1RF, gave a short presentation on antenna polarization, using a HT and a couple of dipole antennas. The receiving antenna was fitted with a small light bulb that lit from the RF energy received. With this set up, Dave was able to practically demonstrate how antenna polarization affects the successful transmission of RF signals. Next, Dave introduced Joe Fitter, K7JOE, and Rick Nicholson, N9UMJ. They gave their presentation on the Southern Indiana Network (SIN) digital radio system. The system was

developed from an interest in being able to communicate between different digital flavors, such as P25, DMR, C4FM (System Fusion), NXDN, or D-Star. The DV4 Mini guys were working on this, but ran out of money. Then other folks took over from there. Utilizing the AMBE 2 chip vocoder, transcoding these modes from one to the other is possible. The guys talked about utilizing different hotspot variations. The low power hotspot is a "Hat" that sets on a Raspberry Pi. This type of hotspot would basically be for use in a small area, such as a home. They are developing high power hotspots, that utilize the same hat on a commercial radio, to give coverage to a larger area. Joe did a live demo over the network to WB9TLH, to show Pi-Star software. There is an email reflector that folks can subscribe to in order to keep up on developments in the system, as well as Pi-Star updates. After Joe and Rick's presentation, Doug Rose, N9DR, did a short "show and tell" of a couple of ISS images he had captured. The meeting was adjourned at 9:01 pm.

INDIANA QSO PARTY COMING UP MAY 4

The Indiana QSO Party is Saturday May 4th, starts at 11AM and ends at 11PM EDT (1500 UTC May 4th to 0300 UTC May 5th).

The objective for Indiana stations is to work all 92 Indiana counties and work as many stations as possible in Indiana and worldwide.

For stations operating outside of Indiana, the goal is to work all 92 Indiana counties and as many Indiana stations as possible.

INQP allows a number of operating categories including: QRP, low and high power single operator, all-out club efforts, multi-operator high power and multi-multi (multi operator and multi transmitters) operation.

Also included are mobile units and rovers moving from county to county and portable setups similar to Field Day. Plaques are awarded for best in Indiana, out of state efforts, and best individual county efforts!

INQP rules include a category for Club Competition that allows an Indiana Amateur Radio Club to have their members that submit contact-logs for an aggregate club score. Members need to list the club on their entry. Plaque for the club with highest aggregate score and awards certificates for second and third place. *[Indianapolis Radio Club members are asked to notate that on their logs.]*

The Indiana exchange is RS(T) plus the county and for all others USA stations it is RS(T) plus state, for Canada RS(T) plus province or territory and all others it is RS(T) plus DX. See INQP site for Indiana county abbreviations. All start with IN and then the county. http://www.hdxcc.org/inqp/counties.html

Logs should be submitted in a digital format, the Cabrillo logging format is preferred. Handwritten logs are accepted but have to be entered manually, so an electronic log is preferred. Logs must be received by June 1st.

The INQP overlaps with a few other QSO parties and contests: the 7QP, NEQP, and the Italian ARI Contest. So, during the INQP many other stations seek contacts from Indiana to fill their logs. The more Indiana stations on the air that day, the more action for everyone!

ARRL PROPOSES CHANGES TO TECH OPERATING SPECTRUM

The ARRL proposed what has been designated RM-11828 by the FCC that would increase Technician level licensees' operating priveleges. The proposal would allow technicians phone privileges at 3.900 to 4.000 MHz, 7.225 to 7.300 MHz, and 21.350 to 21.450 MHz. It would continue RTTY and digital privileges in current Technician allocations on 80, 40, 15, and 10 meters. "TYRO" LICENSE PROPOSED

A new class of license called "Tyro" that was proposed by a Colorado ham back in August of 2017 has been opened to the public for comment. This license would be available to anyone over the age of 11, after completing a "minimal online examination" and mentoring by an Amateur with at least a technician level license. There would be 99 channels in a 70 centimeter sub-band available to Tyro licensees. Additional information is available at
