Highlights from the February Meeting:

The meeting was called to order at 7:30 by club president, David Spoelstra, N9KT. There were around 35 in attendance.

Annual dues of \$20 are due and payable now. Dues can be paid at meetings, or checks made payable to Indianapolis Radio Club can be mailed to club treasurer, Mark Burke, W9MGB, 6347 Green Leaves Rd., Indianapolis, IN 46220.

There were several members of the local chapter of the Society of Professional Engineers in attendance to see Dave Arland's presentation.

Greg, N9NWO, announced that the LaPorte Ham Fest is coming up on February 22. *[See announcement later in this newsletter.]* Jeff, N9NIC, announced that the Indianapolis Hamfest has several time slots available for presentations. These can be anywhere from

15 to 60 minutes in duration. Also, the Radio Club needs volunteers to man the club's table at the Hamfest.

Winter Field Day was held at the Salvation Army facility on Georgetown Road. There were 26 in attendance, with 22 operating. The group made 126 QSOs in approximately 4 hours. The chili, cake, and soft drinks provided by the Salvation Army were greatly appreciated by those taking part in this low-key, social event.

An update on plans for this year's Field Day was given by Jeff, N9NIC. The Indianapolis Radio Club will be joined by the American Legion's club at the Speedway American Legion Post 500. Jeff stressed that this will not be a contest, we will instead be focused on training and learning.

At this point, Mike, WA9FDO, gave a corrected explanation of the solution to the Final Jeopardy answer from the Christmas Party. Next, as a short filler while some technical issues were being finalized for the feature presentation, David, N9KT showed part of a video from the 50th anniversary celebration of the Apollo 11 moon landing put together by the Smithsonian at the Washington Monument.

Next, Dave Arland gave his presentation on this year's Consumer Electronics Show at Las Vegas. Dave talked about the fact that many broadcast engineers are at or past retirement age, due to the fact that there are not enough qualified younger engineers coming up. In Indiana, the broadcasters are working with the state's colleges and universities to get some folks "in the pipeline".

Dave said the CES is 4 days in Las Vegas, made up of 4400 Companies, and 170,000 very tired people. After starting in New York City in 1967 and moving around, the CES ended up in Las Vegas, since its the only place large enough to handle the show. Dave's company, Arland Communications, has 5 full time employees, along with 30 freelancers to cover the show. Dave said that Indiana is one of the leading states in the US for innovation. He said Impossible Foods was at the show with their meat substitutes.

Samsung was showing their modular "Wall" TV, that can be made as big as you want. He had pictures of a Crosley miniature 3" vinyl record player. There were televisions that physically shift from landscape to portrait mode, since that is how most video shot on cell phones is formatted. There were interesting transparent displays shown.

He said the area named "Eureka Park" is where new items are shown. Pet accessories were big. Among the items for pets was an auto feeder for cats, geared toward

households with multiple cats that require different diets. These feeders provide the right food based on the cat's RFID chip, it also has a built in scale to keep the cat from eating too much.

Vintage is big! There were lots of vinyl record players on display, along with Victrola branded table top radios and portable turntables.

NextGen TV (ATSC 3.0) is the next standard for digital video broadcast. ATSC 3.0 will be "IP based", allowing broadcasters to provide more targeted programming and advertising, as well as giving consumers the ability to view "on demand" programming over the air. Dave said there were 20 models of NextGen TVs at the show. NextGenTVs will be on the market the 2nd quarter of 2020. One of the most interesting things on display was a universal translator that was incorporated into an "over the ear" style ear piece. There were also next generation toilets and bidets, and lots of automotive stuff. There were "Nanoleaf" light up panels, that could be used for "light decorating". Lots of overseas-based companies were looking for Angel Funding. Among the more "tongue in cheek" things, was a Smart Potato, that was merely a raw potato with an antenna affixed. There was a prototype "Mega Drone" on display.

As usual, Dave's presentation was very interesting, and very much appreciated!

The meeting adjourned at 9:00.

NEW AMATEUR EXTRA QUESTION POOL RELEASED

If you have been studying the current Extra Class questions, you have until June 30 to take your test with those questions. The new Amateur Extra-class license examination question pool, effective from July 1, 2020, through June 30, 2024, has been released and is available at the National Conference of Volunteer Coordinators (NCVEC) website at, <http://www.ncvec.org/>.

The number of questions in the pool was reduced from 712 to 622. The result was 239 modified questions, 49 new questions, and 139 questions removed due to changes in what was felt to be an abundance of outdated questions, while areas of new technology and subjects were added.
