## **Highlights from the April Meeting:**

In order to comply with the Governor's "stay at home" and social distancing orders, the April meeting was held on line, utilizing the *Zoom* platform. The meeting was called to order at 7:35 by club president, David Spoesltra, N9KT. There were approximately 40 logged in for most of the meeting (At one point, there were 43 logged in). David is going to request the use of the IN ARRL Zoom account for a meeting on INQP day.

The April meeting was our ARRL presentation from Central Division Director Kermit Carlson, W9XA, to bring us up to date on what's going on at the ARRL. There are 15 divisions in the ARRL. The ARRL Board of Directors is elected by the membership of their respective division. The President of the ARRL is Rick Roderick, K5UR. First Vice President is Michael Raisbeck, K1TWF. Second Vice President is Bob Vallio, W6RGG. Vice President for International Affairs is Rod Stafford, W6ROD. Treasurer is Rick Niswander, K7GM. CFO is Diane Middleton, W2DLM.

Kermit stated that at the January meeting of the Board of Directors, the CEO, Howard Michel, WB2ITX, was not re-elected by a split vote of the Board. Barry Shelley, N1VXY, is now serving as interim CEO. The CEO position was advertised in the April edition of QST.

Kermit gave us a review of what has been going on lately with some of the Committees of the Board of Directors:

The DX Advisory Committee rejected a proposed change to the 5 band DXCC requirements. The Public Service Enhancement Working Group is working toward an upgrade. The HF Band Planning Committee is working on trying to regulate Automatic Control Station locations. The Administration and Finance Committee approved a reduction in the membership dues for those below 26 years of age. They are working on possibly a "digital only" membership at no less than 10% less than full membership. Also working on modifying Lifetime membership for those 70 years of age or older. On regulatory issues, AMSAT and ARRL have filed comments with the FCC addressing satellite debris. This will be discussed at the April 23 meeting. From the ARRL EMC (Electromagnetic Compatibility) Committee, chaired by Kermit, work is continuing on trying to regulate non-compliant devices that cause QRN, such as cheap switching power supplies. Wireless charging of Electric Vehicles is being looked at, as related to RF noise and general safety. Kermit noted that recent filings with the ITU suggest there is no difference in QRN levels between Urban and Rural Environments. This is based on a 1975 study, and the data is definitely out-dated. Kermit then went over how and where measurements were made in an updated report. Kermit said the replacement for the OO (Official Observer) Program, FCC Volunteer Monitor Auxiliary has over 2000 hours of volunteer time. There were over 175 applicants to the program, with none turned down. Kermit said contest rules for HF and VHF/UHF are being addressed to keep "robot" stations from making legitimate contacts, similar for DXCC credited contacts. Kermit said the Entry Level License Committee is going to look at establishing "sub-bands" on 80, 40, and 15 meters, including CW, Data, and phone operation, in addition to the current 10 meter allocation. This is currently a recommendation to the ARRL board. Kermit went into details on each of the amateur bands, comparing the present band plans with the proposed ones.

Kermit's presentation was very much appreciated by the club.

#### **Ham Radio News:**

#### W1AW TO LIMIT TRANSMIT SCHEDULE

In response to an executive order from Connecticut Governor Ned Lamont that all non-essential businesses and not-for-profit entities reduce in-person workforces because of COVID-19 pandemic concerns, W1AW has slightly altered its transmission schedule.

W1AW has suspended its morning code practice and qualifying run transmissions. However W1AW's evening transmissions, including qualifying runs, will be sent as usual -- there are no changes to the evening transmit schedule.

W1AW remains closed to the public.

#### ARMED FORCES DAY CROSSBAND TEST POSTPONED

Due to the ongoing COVID-19 response and mitigation actions, the 2020 Armed Forces Day (AFD) Crossband Test scheduled for Saturday, May 9, has been postponed.

Because it's uncertain just when stay-at-home orders will be lifted across the US, AFD planners chose to postpone this year's event, because the government stations that typically support this event may not be available.

Armed Forces Day Crossband Test planners are considering scheduling a November event in honor of Veteran's Day, depending on COVID-19 mitigation actions.

During the AFD Crossband Test, military stations in various locations transmit on selected military frequencies and announce the specific ham frequencies they are monitoring to work radio amateurs.
