#### **Highlights from the September Meeting:**

Meeting called to order via Zoom at 7:35 pm by club president David Spoelstra, N9KT. There were 33 in attendance. Announcements: Club treasurer, Mark Burke, W9MGB, has completed the first step in acquiring the club's 501(c)3 status, making the Indianapolis Radio Club a not-for-profit corporation. Mike Sercer, WA9FDO, announced that the Route 66 special event starts September 12. Dave Miller, K9RTT announced that the VHF contest starts on September 12. David, N9KT, talked about the new radio package on board the International Space Station. There is now an FM repeater on board (see article later in this newsletter). Also, there will be some more satellites launched, including a 15/10 meter repeater. The club's webmaster, Ron Cooper, WB9DKL, asked for input for the website, he mentioned that he has placed DMR codeplugs on the site.

Next, David introduced Steve Van Frank, W9TN, to speak about the Frequency Measuring Test. Steve started out in Indy, and now is in Lafayette. The first Frequency Measurement Test was done in 1931, sponsored by ARRL. Amateurs were the state of the art back then, with some broadcast stations off by over 1 KHz. Today, propagation effects dominate the accuracy of measurements. It's possible to get doppler shifts due to the movement of propagation layers. The indirect method of measurement utilizes a "lossy T", or "ISO-TEE" injecting signal generator for reference. Steve uses a cheap GPS disciplined oscillator for Frequency Reference. Has 10 MHz output that is very accurate. K5CM normally runs the FMT test. Steve uses "Spectrum Lab" software, which is free. The next FMT is November 12.

Meeting adjourned at 9:19.

### FORT WAYNE HAMFEST CANCELED

The Fort Wayne Hamfest Steering Committee has closely followed the progression of CDC, Indiana State, and local Health Dept individual recommendations and large gathering guidance. Consultation with annual volunteers and long-time loyal vendors indicates a growing consensus their attendance would be limited due to pandemic concerns. Our host venue is going to great lengths to minimize infection risk, recently published recommendations stating, "Individuals 65 years of age or older, or those in high-risk categories with underlying health conditions, should consider not attending any event at the facility." The Indiana Governor has extended the mandatory mask-wearing order through the end of October.

In the face of this much credible pandemic risk, the Steering Committee has decided to cancel this year's Fort Wayne Hamfest for the health safety of our valued guests, vendors, and volunteers. We share your disappointment and hope for a swift end to the pandemic so we may again meet for eyeball QSO's and support favorite ham gear vendors at hamfests across the country.

We look forward to hosting a healthy and safe Fort Wayne Hamfest on November 13 & 14, 2021. See you next year!

### FCC APPLICATION FEE PROPOSAL OPEN FOR COMMENTS

Comments are being accepted on the Notice of Proposed Rulemaking (NPRM) in MD Docket 20-270, which proposes application fees for radio amateurs. Formal deadlines for comments and reply comments will be determined once the NPRM appears in the Federal Register.

Comments may be filed now, however, by using the FCC's Electronic Comment Filing System (ECFS), located at, <u>https://www.fcc.gov/ecfs/filings</u>, and posting to MD Docket No. 20-270. The docket is already open for accepting comments, even though deadlines have not yet been set.

### AMATEUR RADIO PACKAGE UPDATED ON ISS

The initial element of the Amateur Radio on the International Space Station (ARISS) next-generation radio system has been installed onboard the ISS, and amateur radio operations using the new gear are now under way. The first element, dubbed the InterOperable Radio System (IORS), was installed in the ISS Columbus module. The IORS replaces the Ericsson radio system and packet module that were originally certified for spaceflight in mid-2000.

Initial operation of the new radio system is in FM cross-band repeater mode using an uplink of 145.99 MHz (CTCSS 67 Hz) and a downlink of 437.800 MHz. System activation was first observed at 01:02 UTC on September 2. Special operations will continue to be announced, ARISS said.

# PAUL GILBERT, KE5ZW, INSTALLED AS ARRL DIRECTOR OF EMERGENCY MANAGEMENT

As another step in ARRL's increased focus on strengthening its emergency communications capabilities and long-standing working relationships with federal and state agencies and private emergency response organizations, ARRL has hired Paul Z. Gilbert, KE5ZW, of Cedar Park, TX as its first Director of Emergency Management.

Gilbert brings more than 30 years of experience in public service in both his professional and amateur radio endeavors. Beginning with his appointment as Emergency Coordinator in 1987, he has held multiple positions in the ARRL Field Organization. Currently in his second term as South Texas Section Manager, he has also served for more than a decade as the West Gulf Division's Assistant Director for Public Service, acting as liaison between Division leadership and local, state, and federal emergency management organizations.

### ARRL SEEKS CHANGES IN 3.4 GHz FCC PROPOSAL

ARRL met by telephone with FCC staff members the week of September 21 to emphasize its opposition to the FCC proposal (Docket No. 19-348, in response to which ARRL filed comments in February 2020) to delete amateur radio from the 3.3 - 3.5 MHz band. The FCC will take final action in the proceeding when it meets on September 30.

ARRL urged that the secondary status for amateur radio in the band be continued. In a series of meetings with Commissioner legal advisors and staff members, ARRL explained how continued secondary use by radio amateurs will not impair or devalue use of this spectrum by future primary licensees, including those intending to provide 5G or other services. ARRL also stressed the various public-benefit uses of the spectrum by amateurs, including ongoing use of television and mesh networks on the west coast of the US as part of efforts to contain wildfires.
