#### **Highlights from the April Meeting:**

Meeting called to order at 7:30 by Club President, David Spoelstra, N9KT. There were 32 in attendance.

KE9AAJ and KD9ZRN were recognized as new hams in attendance.

David reviewed the ways everyone can help benefit the club financially. He also reviewed the club's March POTA activation, and announced our next one, coming up on April 27. David also reminded everyone of the Indiana QSO Party coming up on Saturday, May 4.

Next, Jeff Hammer, N9NIC unveiled the plans for this year's W9JP Field Day, coming up on May 22 & 23. This Field Day event will be essentially a disaster exercise, working

with Marion County RACES and some other area groups. It will also be a "public facing" event to highlight amateur radio to the public. [More info in this newsletter.]

Next, the ARRL, via Central Division Director Carl Luetzelschwab, K9LA; Central Division Vice Director, Brent Walls N9BA; and Indiana Section Manager Bob Burns, AK9R presented Bob Begeman, W9KVK with the ARRL Centurion Award. The ARRL Centurion Award is for Amateurs who have reached 100 years of age (technically Bob's birthday is in August, but we took advantage of our ARRL representatives being at this meeting). Bob has been an ARRL member for 64 years, and he has been very active in the Volunteer Examiner arena. He was first licensed in the early 1950s. Also the Indianapolis Radio Club, via President David Spoelstra, N9KT presented Bob with a certificate thanking him for his loyal service to the VE program, and awarded him with a Lifetime Membership in the club. Following these presentations, cake was enjoyed by those present while our ARRL representatives fielded questions regarding the ARRL.

#### **Ham Radio News:**

#### **INDIANA QSO PARTY COMING UP MAY 4**

On Saturday, May 4, Indiana gets to be a "center of RF activity" for the Indiana QSO Party. This is when all the hams in the world (more or less) are wanting to make contact with all 92 Indiana counties.

The INQP runs from 11:00 am to 11:00 pm local time (1500 to 0300 UTC). Get on the air on SSB or CW on the 160, 80, 40, 20, 15, and 10 meter bands to make as many contacts as you can. Remember, if you are a Technician class operator, you can still operate SSB on the lower part of 10 meters, as well as CW on parts of 15, 40, and 80 meters. If you are a Parks on the Air fan, this is a good opportunity to "kill two birds with one QSO", activating a POTA park while working INQP. Once again, the HDXCC (the club that sponsors the INQP) has designated 10 counties as "Rare Counties", giving the opportunity to get special plaques for operating from these counties that haven't had too much activity in past INQPs. There are also lots of other plaques and certificates available for several different categories.

Don't worry if you don't have much contesting experience. State QSO Parties are great places to "get your feet wet" in contesting. The INQP is one of four QSO Parties going on May 4th, so there should be lots of activities on the bands. Don't forget that it's also "Star Wars Day"!

#### INDIANAPOLIS RADIO CLUB POTA EVENT NEWS

The Indianapolis Radio Club held another Parks On The Air (POTA) activation at Fort Harrison State Park on Saturday, March 23. We had 15 operators attend, and of those, 9 operators made 132 contacts using 2 HF stations. Even though it was around 30 degrees, thanks to Gordon and Ellen Brock's (KD9RUE and KD9RUD) enclosed tent, we had comfortable operating conditions.

We have another activation scheduled for Saturday, April 27, starting around noon at the same place, in front of the Visitor Center at Fort Harrison State Park. Right now the weather looks like we should have a high of 74 degrees, so we should have fun. We will have donuts, coffee, and water on hand.

As on any club activation, everyone will use the club's call (W9JP), but anyone that is registered in the POTA systems will get credit for contacts they make. If you're new to the POTA program or new to HF this is a great chance to get some experience. If you are currently a Technician, or not even licensed, come on out. There will be control operators to help you out.

#### **NEW VENUE FOR ARRL CENTRAL DIVISION CONVENTION**

This year the Central Division Convention will be held in conjunction with the Elkhart East Hamfest (in Elkhart, Indiana) on Saturday August 3.

This is a new venue for the Central Division Convention. VE testing, forums, a flea market and W1AW/9 are some of the planned activities that will take place.

The Hamfest is right along Interstate I-80/I-90 (a.k.a. the Indiana Toll Road) about 15 miles east of South Bend (a 30 minute drive). There are lodging facilities, restaurants and non-ham attractions available in the area (for example, the RV Hall of Fame & Museum and, of course, the University of Notre Dame).

#### ANNUAL ARMED FORCES DAY CROSSBAND EXERCISE

The US Department of Defense (DoD) will host this year's Armed Forces Day (AFD) Crossband Test on May 11, 2024. This annual event is open to all licensed amateur radio operators and will not impact any public or private communications. For more than 50 years, military and amateur stations have taken part in this event.

The AFD Crossband Test is a unique opportunity to test two-way communications between military communicators and radio stations in the Amateur Radio Service (ARS), as authorized in 47 CFR 97.111. These tests provide opportunities and challenges for radio operators to demonstrate individual technical skills in a tightly controlled exercise scenario that does not impact any public or private communications. Military stations will transmit on selected military frequencies and will announce the specific ARS frequencies monitored.

#### **FCC CORES SYSTEM NOW REQUIRES 2FA**

Effective March 29th, the FCC has started requiring 2-factor authentication to access the Commission Registration System (CORES). This is where licensees pay any application or regulatory fees, manage or reset a password on an existing FRN, or request a new FRN. After you enter your user name and password at <a href="https://apps.fcc.gov/cores/userLogin.do">https://apps.fcc.gov/cores/userLogin.do</a> you will be notified to enter the temporary PIN that has been sent to your email address on file. After you do that, it's business as usual. When I tried it, on a Friday evening at 7:00 pm, within 30 seconds or less I had received my temporary PIN from the system. Anyone who does on-line banking or accessed any government web sites is already used to this extra layer of security, but resources are available for those who need assistance with the system. #### From the March, 2001 Amachewer:

Last month, the FCC designated the ARRL-VEC, the W5YI-VEC and the W4VEC Volunteer Examiners Club of America as Club Station Call Sign Administrators. Club station applicants may file via any of the three FCC-designated CSCSA's using either NCVEC Form 605 or W4VEC Form CSCSA to file. The new CSCSA's receive and process hard-copy applications and submit the information electronically to the FCC.
